## **Requirements for the application form**

The candidate must:

- Submit the application in English.
- Provide contact details such as email, postal address and telephone number.
- Summarise the history and current status of the family company in no more than 250 words.
- Summarise the project in no more than 250 words.
- Summarise why the family company would be a worthy winner of The PFV Prize in no more than 150 words.
- Supply media coverage that is evidence of excellence.
- Provide top line revenue and net profit figure for the previous year, current year and a forecast for the next year.
- Nominate three independent people (with mobile and email contacts) who will vouch for the applicant company and for its reputation.
- Guarantee the authenticity and truth of all material and data supplied for The PFV Prize.
- Be willing to answer further questions put by The PFV Selection Jury and their representatives if required.
- Not contact any member of the PFV Selection Jury directly or indirectly (such action will invalidate the nomination).
- Only contact the officially nominated PFV representative.
- Be willing to allow the applicant's company name and family name to be used in the worldwide announcement of The PFV Short List and The PFV Prize if selected for either.
- Submit the fully completed application not later than 24 hours GMT on 30th October 2020. Later amends or additions, unless specifically requested by the PFV official representative, will not be admitted.

## **Rules for nomination to The PFV Prize**

The candidate must:

- Be legally incorporated as a business.
- Be entirely owned by one family.
- Have (or had) the involvement in the day to day management of the business of at least two generations of the same family.
- Be able to demonstrate manifest intent to continue the family business, combined with evidence of the transmission of know-how and experience to younger family members.
- Present a development project (new or underway) that demonstrates sustainability, innovation and original thinking, proving that family business can be a powerful tool to respond to the social and environmental challenges of our time.
- Have a reputation for excellence in their chosen field.
- Have a proven record of ethical behaviour with care for their local community and for the environment.
- Give evidence of sound financial history and performance enough to support continuity and future development.
